## Report on Lendi Innovation and Start-up Policy (LISP) Online sessions

Topic: Lendi Innovation and Start-up Policy (LISP) for students and faculty -2021

Date: 08-04-2021 Platform: Online (Zoom Meeting)

The Lendi Innovation and Incubation Cell has initiated Online Sessions on Lendi Innovation and Start-up Policy (LISP) for IIC and EDC calendar year 2020-21. Session -1 had been taken by Dr. A. Pankusam, Professor, Convener IIC and LISP at 2.30 PM on 08-04-2021. The topic revolves around framing of Lendi Innovation and Startup Policy (LISP). For the first fifteen minutes he addressed about IIC and EDC of LIET. The initiatives of Innovation Cell are the Smart India Hackathon, Institution's Innovation Council, and Institutions on Innovation Achievements. The main objective of LISP is to be established is to strengthen the campus innovation and start the activity. He then briefed on LISP, its various dimensions and the Thrust areas. - 7 Norms for Faculty Start-ups
- 8 Pedagogy and Learning Interventions for Entrepreneurship Development
- 9 Collaboration, Co-creation, Business Relationships and Knowledge Exchange
- 10 Entrepreneurial Impact Assessment
